



## LIMITED WARRANTY

### American Legends Vinyl Clad Steel Overhead Carriage House Doors

#### ONE YEAR DOOR WARRANTY, LIMITED DOOR SECTION EXTENDED WARRANTY, AND LIMITED LIFETIME DOOR SECTION EXTENDED WARRANTY

(a) Seller's Obligation:

**WARRANTY:** Fimbel Architectural Door Specialties Vinyl-Clad Steel Carriage House Doors are guaranteed to be free of commercial defects in materials and workmanship for a period of one year following shipment. Fimbel Architectural Door Specialties will repair or replace at its option any material which proves to be defective under normal use provided same has been properly finished, and is not misused, abused, damaged, or subjected to acts of god or adverse atmospheric conditions; provided such material is returned freight prepaid to Whitehouse, New Jersey during the term of said guarantee period. Material adjudged defective by Fimbel Architectural Door Specialties will be repaired or replaced at Fimbel Architectural Door Specialties' option and expense and will be returned freight prepaid. Materials not properly finished, not used in a normal manner, or materials that have been abused or damaged will be repaired or replaced at the customer's expense, and shipped freight collect.

**Limited Door Section Extended Warranty:** Fimbel Architectural Door Specialties further warrants the Vinyl Clad Steel sections for the above mentioned products not to crack, split, or peel for a period of 15 years, providing the sections have been left natural white, factory finished white, or field finished white. Door sections finished in colors other than white by Fimbel Architectural Door Specialties are warranted for a period of 10 years, only light colors are offered. **We do not recommend field finishing in any color other than white.** Field finishing with any color other than white is done at the customer's risk and will void the warranty. Warranties are nontransferable.

**Limited Lifetime Door Section Extended Warranty:** Fimbel Architectural Door Specialties further warrants the PVC Composite sections the above mentioned products against water absorption, rotting, termite damage, and rusting through for life. Warranties are nontransferable.

If the need does arise to replace a section or sections, they will be provided as they were originally ordered from the factory. If they were originally ordered unfinished they will provided as such. If they were factory finished, they will be provided as such. Fimbel Architectural Door Specialties cannot guarantee new finished sections will perfectly match the existing sections, as fading does occur over time. They shall also not be responsible for supplying finished sections for doors finished outside the factory. In addition, new unfinished sections may be a slightly different color white than the existing section(s). Fimbel Architectural Doors Specialties accepts no responsibility for this and recommends the doors to be painted white. This will ensure consistent color and is an absolute benefit. This in no way is a detriment to the door and in no way affects the warranty.
